S3: Mrs P

There is an adorable 6 year old boy with Down syndrome and other additional needs living in Bristol. He should be in year 2 at school but has no school place. The LA have advised that they also have no alternative learning provision that can meet his needs whilst he is out of school. A breakdown between the LA and his old school has meant that a bespoke package agreed 6 months ago at an emergency Annual Review has still not been provided. A charity stepped in two months ago to offer the services of a mentor for the vulnerable boy whilst he was out of school and receiving no other services, let alone education, but the LA failed to confirm payment. As such, the mentoring never started. LD CAMHS, who were supporting the boy and his family, have been cut back to a team of just two (from 7 or 8) and are about to discharge him from their services. Social care provision was agreed several months ago for just a few hours a week outside school hours only, and yet there is no actual

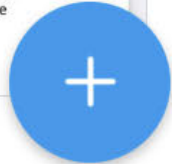
social care happening as none can be found that fit the requirements laid down by the Social Care team.

The entire send system is broken.
