Purpose of Report: To update members following concerns about inappropriate use of social media by staff and to reach a decision on the way forward.

Background

- In July 2022 concerns were raised about the use of social media by council staff and the legal team were asked to carry out an investigation by the then Chief Executive. The report was presented to People Scrutiny Commission on the 26 September 2022 and can be found here: 3. SEND Fact-finding report - Amended 13.10.22 Redacted.pdf
- 2. Further to the completion of the report, Members voted in a golden motion on the 18 October 2022 to request the Mayor to commission an independent investigation. This was not taken forward by the then Cabinet.
- 3. Since then, ongoing concerns have been raised that the matter was not fully addressed through an independent investigation, leaving uncertainty about the extent of social media use by staff. There have been ongoing requests for an external investigation.
- 4. In July 2025 in the Children and Young People's Committee the request was again made in public forum to consider an external investigation and a debate ensued. As a consequence, the Chair of the committee has asked that a report be brought to the August Committee to consider the matter further.

- 5. Improving the support we provide to children and young people with SEND is an urgent priority for the Council. We have strengthened how we work together with all stakeholders and continue to refine our approach, with the aim that that children, young people, and their families are able to experience real and lasting improvements in their lives.
- 6. Since July 2022, there have been significant changes across the council, and the culture of collaboration and partnership has strengthened. Co-production is now at the heart of our work, supported by our Co-Production Charter, Memorandum of Understanding, and jointly developed SEND and Inclusion policy. We are determined that these developments should continue to underpin the positive partnerships that guide our approach to SEND and inclusion.
- 7. There is no evidence to suggest that the concerns raised in 2022 continue today. Should any concerns arise related to current practice, families are invited to bring these to the attention of senior officers.

Recommendation:

That the Committee for Children and Young People consider/approve one of the following two options:

 To request the Executive Director: Children and Education to commission an independent investigation into the issues identified in 2021/2 within the report as well as more widely; and to delegate authority to the Executive Director: Children and Education to identify a suitably qualified reviewer, and determine the specific terms of reference/scope of the investigation in consultation with the members of the Children and Young People Policy Committee.

Should this option be selected we will work closely and confidentially with any parents or staff directly affected in the spirit of confidentiality and transparency. We will also return to update the Committee with outcomes of the investigation.

Or

2. That no further action be taken on this matter.
